# QUENCHED LARGE DEVIATIONS FOR ONE DIMENSIONAL NONLINEAR FILTERING*

#### Abstract

Consider the standard, one dimensional, nonlinear filtering problem for diffusion processes observed in small additive white noise: $d X_{t}=b\left(X_{t}\right) d t+d B_{t}, d Y_{t}^{\varepsilon}=\gamma\left(X_{t}\right) d t+\varepsilon d V_{t}$, where $B ., V$. are standard independent Brownian motions. Denote by $q_{1}^{\varepsilon}(\cdot)$ the density of the law of $\Xi_{1}$ conditioned on $\sigma\left(Y_{t}^{\varepsilon}: 0 \leq t \leq 1\right)$. We provide "quenched" large deviation estimates for the random family of measures $q_{1}^{\varepsilon}(x) d x$ : there exists a continuous, explicit mapping $\overline{\mathcal{J}}: \mathbb{R}^{2} \rightarrow \mathbb{R}$ such that for almost all $B$., $V$., $\overline{\mathcal{J}}\left(\cdot, X_{1}\right)$ is a good rate function, and for any measurable $G \subset \mathbb{R}$,

-\inf _{x \in G^{o}} \overline{\mathcal{J}}\left(x, X_{1}\right) \leq \liminf _{\varepsilon \rightarrow 0} \varepsilon \log \int_{G} q_{1}^{\varepsilon}(x) d x \leq \limsup _{\varepsilon \rightarrow 0} \varepsilon \log \int_{G} q_{1}^{\varepsilon}(x) d x \leq-\inf _{x \in \bar{G}} \overline{\mathcal{J}}\left(x, X_{1}\right) .
$$

1. Introduction and statement of results. Consider the following one dimensional filtering problem, where the signal process $X$. and the observation process $Y_{.}^{\varepsilon}$, parametrized by a "small noise intensity" $\varepsilon$, are

& d X_{t}=b\left(X_{t}\right) d t+d B_{t}, \quad X_{0} \sim p_{0}(\cdot), \\
& d Y_{t}^{\varepsilon}=h\left(X_{t}\right) d t+\varepsilon d V_{t} . \tag{1.1}
\end{align*}
$$

Here, B., V. are independent standard one dimensional Brownian motions, and the functions $b, h, p_{0}$ satisfy the following assumptions: ${ }^{1}$

\text { (A-1) } & b, h, b^{\prime}, h^{\prime} \text { are Lipschitz functions, } \\
\text { (A-2) } & h^{\prime}(\cdot) \geq h_{0}>0, \\
\text { (A-3) } & \left|\log p_{0}(x)-\log p_{0}(y)\right| \leq c(1+|x|+|y|)|x-y|, x, y \in \mathbb{R} \text {, and } \\
& p_{0} \text { is uniformly bounded. }
\end{array}
$$

For technical reasons, we need to impose the following additional restriction:
(A-4) $h^{\prime} b, h^{\prime} h, h^{\prime \prime}, h b$ are Lipschitz functions and $\lim _{|x| \rightarrow \infty} h^{\prime \prime}(x)=0$.
(A-4) implies that, outside large compacts, the observation function $h$ is essentially linear. Let $\Omega_{1}=\Omega_{2}=C([0,1] ; \mathbb{R}), \Omega=\Omega_{1} \times \Omega_{2}, \mathcal{F}_{i}$ be the Borel $\sigma$-algebra on $\Omega_{i}$,

[^0]$i=1,2$, and $\mathcal{F}$ be the Borel $\sigma$-algebra on $\Omega$; let $P_{1}, P_{2}$ denote the Wiener measure on $\Omega_{1}, \Omega_{2}$, and $P=P_{1} \otimes P_{2}$. We define $B_{t}(\omega)=\omega_{1}(t), V_{t}(\omega)=\omega_{2}(t), 0 \leq t \leq 1$. The pair $(B, V)$ is then distributed according to $P$. The solution $\left(X, Y^{\varepsilon}\right)$ of the $\operatorname{SDE}$ (1.1) is then an $\mathcal{F}$-measurable, $C\left([0,1] ; \mathbb{R}^{2}\right)$-valued, random variable.

Let $\mu_{t}^{\varepsilon}(\cdot)$ denote the conditional law of $X_{t}$ conditioned on $\mathcal{Y}_{t}^{\varepsilon}=\sigma\left\{Y_{s}^{\varepsilon}, 0 \leq s \leq t\right\}$, which we consider as an $\mathcal{F}$-measurable map from $\Omega$ to $M_{1}(\mathbb{R})$, the space of probability measures on $\mathbb{R}$. Note that $\mu_{t}^{\varepsilon}$ is in fact measurable with respect to the $\varepsilon$-dependent $\sigma$-algebra $\mathcal{Y}_{t}^{\varepsilon} \subset \mathcal{F}$.

It is known that $\mu_{t}^{\varepsilon}$ is absolutely continuous, with $\mu_{t}^{\varepsilon}(d x)=q_{t}^{\varepsilon}(x) d x$, and that as $\varepsilon \rightarrow 0$, the conditional law $\mu_{1}^{\varepsilon}(d x)=q_{1}^{\varepsilon}(x) d x$ of $X_{1}$, given $\mathcal{Y}_{1}^{\varepsilon}$, converges to the Dirac measure $\delta_{X_{1}}$. (All these facts can be found, e.g., in [7].) In particular, $X_{1}$ is measurable with respect to the limiting $\sigma$-algebra $\mathcal{Y}_{1}^{0}$, since $h$ is one-to-one. It is known from the results of Picard [7] that the conditional law $\mu_{1}^{\varepsilon}$ has a variance of order $\varepsilon$ and can be well approximated by a Gaussian law, which is given by an extended Kalman filter.

Our goal in this paper is to establish a large deviations result in the following sense. Let $G$ be a measurable subset of $\mathbb{R}$. By the above remarks, we know that on the event $\left\{X_{1} \notin \bar{G}\right\}, \mu_{1}^{\varepsilon}(G) \rightarrow 0, P$-almost surely. It turns out that it goes to zero at exponential speed, i.e., roughly like $\exp \left[-c_{1}(G) / \varepsilon\right]$. What is the value of $c_{1}(G)=-\lim \varepsilon \log \mu_{1}^{\varepsilon}(G)$ (if this limit exists), the "rate function" that tells us at which speed the quantity $P\left(X_{1} \in G \mid \mathcal{Y}_{1}^{\varepsilon}\right)$ goes to zero, whenever $X_{1} \notin \bar{G}$ ? Clearly $c_{1}(G)$ must depend on $X_{1}$ (at least intuitively through its distance to $\bar{G}$ ), and we shall see that this is indeed the case. There is no surprise in the fact that $c_{1}(\cdot)$ is random, since it tells us at which exponential speed the random measures $\mu_{1}^{\varepsilon}$ converge to the random measure $\mu_{1}^{0}=\delta_{X_{1}}$. Our results show that $c_{1}$ does not depend on anything else, in the sense that, conditionally on $\sigma\left(X_{1}\right)$, it is $P$-almost surely constant.

We call our result "quenched" (borrowing that terminology from the theory of random media), meaning that the randomness of the observation process is frozen. One could also discuss a "semiquenched" large deviations statement by computing the $P_{1}$-almost sure limit (if it exists) of

while an "annealed" large deviations result would describe the asymptotic behavior of

$$
\varepsilon \log E \int_{G} q_{1}^{\varepsilon}\left(x+X_{1}\right) d x
$$

Finally, one could also consider large deviations questions at the level of the conditional measure itself, for example questions concerning the rate of decay of probabilities of the form $P\left(q_{1}^{\varepsilon}(x) d x \in A\right)$, with $A$ a measurable subset of the space of probability measures on $\mathbb{R}$. We hope to study all these elsewhere.

Let us now state our result. Define

$$
\overline{\mathcal{J}}\left(x, X_{1}\right)=\int_{X_{1}}^{x}\left(h(y)-h\left(X_{1}\right)\right) d y
$$

Our main result is the following theorem. For standard definitions concerning the large deviation principle (LDP), see [3]. For a set $G \subset \mathbb{R}$, we denote by $G^{o}$ its interior and by $\bar{G}$ its closure.

Theorem 1.1. Assume (A-1)-(A-4). Then the family of (random) probability measures $q_{1}^{\varepsilon}(x) d x$ satisfies a quenched LDP (on the space $\mathbb{R}$ equipped with the standard Euclidean norm) with continuous good rate function $\overline{\mathcal{J}}\left(\cdot, X_{1}\right)$. That is, for any measurable set $G \subset \mathbb{R}$,

\begin{align*}
-\inf _{x \in G^{o}} \overline{\mathcal{J}}\left(x, X_{1}\right) & \leq \liminf _{\varepsilon \rightarrow 0} \varepsilon \log \int_{G} q_{1}^{\varepsilon}(x) d x \leq \limsup _{\varepsilon \rightarrow 0} \varepsilon \log \int_{G} q_{1}^{\varepsilon}(x) d x \\
& \leq-\inf _{x \in \bar{G}} \overline{\mathcal{J}}\left(x, X_{1}\right), \quad P-a . s \tag{1.2}
\end{align*}
$$

In fact, we have the estimate, valid for any fixed compact set $K_{0} \subset \mathbb{R}$,

$$
\begin{equation*}
\lim _{\varepsilon \rightarrow 0} \sup _{x \in K_{0}}\left|\varepsilon \log q_{1}^{\varepsilon}(x)+\overline{\mathcal{J}}\left(x, X_{1}\right)\right|=0, \quad P-\text { a.s. } \tag{1.3}
\end{equation*}
$$

(It will be obvious from the proof that the fixed time 1 can be replaced by any fixed time $t \in(0, \infty)$; that is, the statement of Theorem 1.1 remains true with $q_{t}^{\varepsilon}$ and $X_{t}$ replacing $q_{1}^{\varepsilon}$ and $X_{1}$.)

Remarks.

1. In the particular case $h(x)=x$, Theorem 1.1 can be deduced from the results of [10].
2. The reader could wonder why the statement (1.2) is equivalent to the large deviations principle on $\mathbb{R}$ for $P$-almost $\omega$, since in (1.2), the null set on which the statement does not hold true may depend on $G$. Note, however, that once the inequalities in (1.2) hold true for each interval $G=(a, b)$ on a set of full measure $\Omega_{a, b}$, we can set

$$
\Omega^{\prime}=\cap_{a, b \in \mathbb{Q}} \Omega_{a, b}
$$

and conclude that $P\left(\Omega^{\prime}\right)=1$ while (1.2) holds true for all $\omega \in \Omega^{\prime}$ and all open intervals $G$ with rational endpoints. Since the latter are a base for the topology on $\mathbb{R}$, one concludes (see, e.g., [3, Theorem 4.1.11]) that the full LDP holds for each $\omega \in \Omega^{\prime}$.

We conclude this introduction with some comments about previous work and possible applications and extensions of our result. Our motivation for the study of the large deviations of the optimal filter is their utility in a variety of applications such as tracking (see [9]) or the study of the filter memory length (see [1]). In the one dimensional linear observation case studied in [10], precise pointwise estimates can be derived by comparison with the linear filtering problem, whose (Gaussian) solution is known explicitly. In contrast, here, the main tool used in the proof of Theorem 1.1 is the representation, due to Picard [7], of the density $q_{1}^{\varepsilon}$ in terms of an auxiliary suboptimal filter, and the availability of good estimates on the performance of this suboptimal filter. These results are not available in the general multidimensional case. When they are, e.g., in the setup discussed in [8], we believe our analysis can be carried through. Hence, while our result is presently limited to one dimension, we expect that its multidimensional extension to the case where the dimensions of the state and observation coincide, and the observation function is one-to-one, could be deduced from the results of [8]. Extension to the case where the dimension of the observation is smaller than the dimension of the state (which is the most relevant case for applications) would require completely new additional ideas, since the result would be of a completely different nature (the limiting measure is no longer necessarily a Dirac measure, and even when it is, the convergence to the Dirac measure is at different speeds for different coordinates).

We finally note that Hijab [4] has derived a (path) quenched large deviations for the conditional density for systems in which both the signal and the observation noises are small. This is related, by a time change, to looking at short times (of order $\varepsilon T$ ) of the filtering equations

$$
\begin{aligned}
d X_{t}^{\varepsilon} & =\frac{1}{\varepsilon} \bar{b}\left(X_{t}^{\varepsilon}\right) d t+d B_{t}, \quad X_{0}^{\varepsilon}=x \\
d Y_{t}^{\varepsilon} & =h\left(X_{t}^{\varepsilon}\right) d t+\varepsilon d V_{t}
\end{aligned}
$$

(Hijab's results are not stated in this way, but are equivalent to the description given here. Note that his setup is more general than ours in that it applies to the multidimensional setup and allows for general regular diffusion coefficients.) Hijab's results are not directly comparable with the LDP we derive here because of the different time interval on which they apply, and also because of the different type of conditioning. (His statement looks at the conditional density as a continuous functional of the observation trajectory, and considers the LDP when this trajectory is frozen. It is thus not directly applicable as a quenched statement.)

We refer the reader to [5] for a general introduction to stochastic calculus and stochastic differential equations, and to [6] for an exposition of nonlinear filtering theory.

Convention. Throughout the paper, when relevant, we make explicit on what parameters constants depend, even if the actual value of the constant may change from line to line. When nothing explicit is mentioned, i.e., a generic constant $C$ is used, it is understood that it may depend on the trajectories $\{X\},.\{V$.$\} , but not on$ $\varepsilon$. For $\infty>t>0$, we use the notation $\|f\|_{t}=\sup _{s \leq t}|f(s)|$, with $\|f\|:=\|f\|_{1 / \varepsilon}$. Finally, we use $\theta^{t}$ to denote the shift operator, e.g., $\theta^{t} \tilde{\tilde{m}}(\cdot)=\tilde{m}(t+\cdot)$.
2. Picard's formulation and a path integral. The filtering problem we are going to analyze is (1.1), and the assumptions (A-1)-(A-4) will be assumed to hold throughout the paper. We also note that since nothing is changed (in terms of the filtering problem) by adding a constant to the observation function $h$, we may and will assume throughout the paper that $h(0)=0$.

It is known from the results of Picard [7] that the conditional law $q_{1}^{\varepsilon}(x) d x$ has a small variance, and that there exist finite dimensional filters that provide good approximations of the unknown state. We shall now recall the formula derived by Picard [7] for $q_{1}^{\varepsilon}(x)$, which was used there to study approximate filters. It will be an essential tool for our large deviation results.

Define the approximate filter

$$
d M_{t}^{\varepsilon}=b\left(M_{t}^{\varepsilon}\right) d t+\frac{1}{\varepsilon}\left(d Y_{t}^{\varepsilon}-h\left(M_{t}^{\varepsilon}\right) d t\right)
$$

with $M_{0}^{\varepsilon}=0$, and let $\bar{m}_{s}=M_{1-s}^{\varepsilon}$ and $\tilde{m}_{s}=\bar{m}_{\varepsilon s}, s \in[0,1 / \varepsilon]$.
One of the main contributions of Picard in [7, Proposition 4.2] was to express the conditional density $q_{1}^{\varepsilon}(x)$ in terms of the law of an auxiliary process $\left\{\bar{X}_{1-t}^{x}, 0 \leq t \leq 1\right\}$, which fluctuates backward in time, starting at time 1 from the position $x$, around the trajectory of the approximate filter $M_{.}^{\varepsilon}$. Performing a time change and a Girsanov transformation, Picard's result can be rewritten as follows. ${ }^{2}$ Define the process

$$
d \tilde{Z}_{s}^{\varepsilon, x}=\left[-h\left(\tilde{Z}_{s}^{\varepsilon, x}\right)+\tilde{m}_{s} h^{\prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right)-\varepsilon b\left(\tilde{Z}_{s}^{\varepsilon, x}\right)\right] d s+\sqrt{\varepsilon} d \tilde{W}_{s}, \quad \tilde{Z}_{0}^{\varepsilon, x}=x
$$

[^1]with $\widetilde{W}$ a standard Brownian motion, independent of $B ., V$.. Throughout, we let $\mathbb{E}$ and $\mathbb{P}$ denote expectations and probabilities with respect to the law of the Brownian motion $\widetilde{W}$. Then a version of the conditional density of $X_{1}$, given $\mathcal{Y}_{1}^{\varepsilon}$, is given by
\[

q_{1}^{\varepsilon}(x)=\frac{\rho_{1}^{\varepsilon}(x)}{\int_{\mathbb{R}} \rho_{1}^{\varepsilon}(x) d x}, \tag{2.1}
\end{equation*}

where
$\rho_{1}^{\varepsilon}(x):=e^{-F\left(x, \tilde{m}_{0}\right) / \varepsilon} \mathbb{E}\left[\exp \left(I_{\varepsilon}\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}, 0\right)+\int_{0}^{1 / \varepsilon} g_{1}\left(\tilde{Z}_{s}^{\varepsilon, x}, \tilde{m}_{s}\right) d s+\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} g_{2}\left(\tilde{Z}_{s}^{\varepsilon, x}, \tilde{m}_{s}\right) d s\right)\right]$,
and

$$
\begin{aligned}
& F(z, m)=\int_{0}^{z}(h(y)-h(m)) d y-m h(z)+h(m) z \\
& I_{\varepsilon}(z, m)=\log p_{0}(z)+\frac{1}{\varepsilon} F(z, m) \\
& g_{1}(z, m)=-m h^{\prime}(z) b(z)+\frac{m h^{\prime \prime}(z)}{2}+h(z) b(z)-\frac{h^{\prime}(z)}{2}-\varepsilon b^{\prime}(z)-h(z) b(m), \\
& g_{2}(z, m)=h(z) h(m)-\frac{h^{2}(m)}{2}-m h(z) h^{\prime}(z)+\frac{m^{2} h^{\prime}(z)^{2}}{2}
\end{aligned}
$$

Note that assumptions (A-1)-(A-4) ensure that, for each given $m, g_{1}(\cdot, m), g_{2}(\cdot, m)$ are Lipschitz functions with Lipschitz constant uniformly bounded for $m$ in compacts.

It is important to note that, above and throughout the paper, expressions of the form $\mathbb{E}(\cdot)$ may still be random, due to their possible dependence on $B ., V$.. Thus, any equality between such expressions is to be understood in an almost sure sense. We will not explicitly mention this in what follows.

Equipped with (2.2), one is tempted to apply standard tools of large deviations theory, viz. the large deviations principle for $\tilde{Z}^{\varepsilon, x}$ and Varadhan's lemma, to the analysis of the exponential rate of decay of the $\mathbb{P}$ expectation in (2.2). This temptation is quenched when one realizes that, in fact, the rate of growth of $\rho_{1}^{\varepsilon}$ is exponential in $1 / \varepsilon^{2}$, and it is only after normalization that one can hope to obtain the relevant $1 / \varepsilon$ asymptotics. This fact, unfortunately, makes the analysis slightly more subtle. In the next section, we present several lemmas, whose proof is deferred to section 4, and show how to deduce Theorem 1.1 from these lemmas. Before closing this section, however, we state the following easy a priori estimates. Recall that, according to our convention, $\|X\|_{1}=\sup _{s \leq 1}\left|X_{s}\right|$.

Lemma 2.1. $\|X\|_{1}<\infty, P$-almost surely,

\||\tilde{m}|\|:=\limsup _{\varepsilon \rightarrow 0} \sup _{t \in[0,1 / \varepsilon]}\left|\tilde{m}_{t}\right|<\infty, \quad P-\text { a.s. }
$$

and for $T_{\varepsilon}=\log (1 / \varepsilon),\left|\left|\left|\tilde{m}_{X}\right| \|:=\sup _{s \in\left[0, T_{\varepsilon}\right]}\right| \tilde{m}_{s}-X_{1}\right|$,

$$
\begin{equation*}
\limsup _{\varepsilon \rightarrow 0}\| \| \tilde{m}_{X}\| \|=0, \quad P-a . s \tag{2.3}
\end{equation*}
$$

Further, there exists a constant $C_{V, X}$ depending only on $\{X ., V$.$\} such that$

$$
\sup _{s \in\left[0, T_{\varepsilon}\right]}\left|\tilde{m}_{s}-X_{1}\right| \leq C_{V, X} / \sqrt{T_{\varepsilon}}, \quad P-a . s .
$$

Proof of Lemma 2.1. The statement that $\|X\|_{1}<\infty$ is part of the statement concerning existence of solutions to the $\operatorname{SDE}$ (1.1). Next, we prove that

$$
\begin{equation*}
\limsup _{\varepsilon \rightarrow 0} \sup _{t \leq 1}\left|M_{t}^{\varepsilon}\right|<\infty \tag{2.4}
\end{equation*}
$$

Indeed, fix constants $C=C\left(\|X\|_{1}\right)$ and $\varepsilon_{0}$ such that $h(y)-h(x)+\sup _{\varepsilon \leq \varepsilon_{0}} \varepsilon b(x)<0$ for all $x \geq C$ and $|y| \leq\|X\|_{1}$ (this is always possible because $b, h$ are Lipschitz and $\left.h^{\prime}>h_{0}\right)$. Define the stopping times $\tau_{0}=0, \theta_{0}=0$ and

$$
\tau_{i}=\inf \left\{t>\theta_{i-1}: M_{t}^{\varepsilon}=C\right\}, \quad \theta_{i}=\inf \left\{t>\tau_{i}: M_{t}^{\varepsilon}=C+1\right\}
$$

By definition, $M_{t}^{\varepsilon} \leq C+1$ for $t \in\left[\tau_{i}, \theta_{i}\right]$, while for $t \in\left[\theta_{i}, \tau_{i+1}\right]$ it holds that for all $\varepsilon<\varepsilon_{0}$,

M_{t}^{\varepsilon}=M_{\theta_{i}}^{\varepsilon}+\int_{\theta_{i}}^{t}\left[b\left(M_{s}^{\varepsilon}\right)+\frac{1}{\varepsilon}\left(h\left(X_{s}\right)-h\left(M_{s}^{\varepsilon}\right)\right)\right] d s+V_{t}-V_{\theta_{i}} \leq C+1+2\|V\|_{1}
$$

We conclude that $\sup _{t \leq 1} M_{t}^{\varepsilon} \leq C+1+2\|V\|_{1}<\infty$ for all $\varepsilon<\varepsilon_{0}$. A similar argument shows that $\inf _{t \leq 1} M_{t}^{\varepsilon} \geq-\left(C+1+2\|V\|_{1}\right)$.

To see the stated convergence of $\tilde{m}_{s}$ to $X_{1}$, recall that $X_{t}$ and $V_{t}$ are almost surely $\operatorname{Hölder}(\eta)$ continuous for all $\eta<1 / 2$. Fix $t_{0}=1-2 \varepsilon T_{\varepsilon}, t_{1}=1-\varepsilon T_{\varepsilon}, \delta_{\varepsilon}=1 / \sqrt{T_{\varepsilon}}$, and write $Y_{t}=M_{t}^{\varepsilon}-X_{1}$. With these notations,
$Y_{t}=Y_{t_{0}}+\int_{t_{0}}^{t}\left[b\left(M_{s}^{\varepsilon}\right)+\frac{h\left(X_{s}\right)-h\left(X_{1}\right)}{\varepsilon}\right] d s+\frac{1}{\varepsilon} \int_{t_{0}}^{t}\left(h\left(X_{1}\right)-h\left(M_{s}^{\varepsilon}\right)\right) d s+\left(V_{t}-V_{t_{0}}\right)$.
By the first part of the lemma, it holds that $\left|Y_{t_{0}}\right| \leq C$. We first show that for some $\tau \in\left(t_{0}, t_{1}\right)$ it holds that $\left|Y_{\tau}\right| \leq \delta_{\varepsilon}$. Indeed, assume without loss of generality that $Y_{t_{0}}>\delta_{\varepsilon}$. Then, by the Hölder property of $X$. and $V$., it holds that

Hence, if a $\tau$ as defined above does not exist, then necessarily, using the Lipschitz continuity of $h$,

Indeed, let $\theta^{\prime}=\inf \left\{\tau<t \leq 1: Y_{t}=2 \delta_{\varepsilon}\right\}$. Repeating the argument above, we now obtain that if such a $\theta^{\prime}$ exists, it must hold that for some $\theta<2 \varepsilon T_{\varepsilon}$,

The following are the auxiliary lemmas alluded to above. The proof of the first, Lemma 3.1, is standard, combining large deviations estimates for solutions of SDEs (see, e.g., [2, Theorem 2.13, p. 91]) with Varadhan's lemma (see, e.g., [3, Theorem 4.3.1, p. 137]), and is omitted.

& \leq\left(\mathbb{E} \exp \left[\frac{p(1+\delta)}{\sqrt{\varepsilon}} \int_{0}^{1 / \varepsilon} h\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d \tilde{W}_{s}-\frac{(1+\delta)^{2} p^{2}}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d s\right]\right)^{\frac{1}{p(1+\delta)}} \\
& \\
& \times\left(\mathbb{E} \exp \left[-\frac{p^{\prime} q}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d s+\frac{C q}{\varepsilon} \int_{0}^{1 / \varepsilon}\left|\tilde{Z}_{s}^{\varepsilon, x}\right| d s\right]\right)^{\frac{1}{q(1+\delta)}} \\
& =\left(\mathbb{E} \exp \left[-\frac{p^{\prime} q}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d s+\frac{C q}{\varepsilon} \int_{0}^{1 / \varepsilon}\left|\tilde{Z}_{s}^{\varepsilon, x}\right| d s\right]\right)^{\frac{1}{q(1+\delta)}} .
\end{aligned}
$$

Since $h(z)^{2} \geq h_{0}^{2} z^{2}$ (recall that $h(0)=0!$ ), there exist $C(\delta)>0, C_{1}(\delta)$ such that $p^{\prime} q h(z)^{2} / 2-C q|z| \geq C(\delta) z^{2}-C_{1}(\delta)$, and hence, with $C_{2}(\delta)=C+C_{1}(\delta) \delta / p(1+\delta)$
(all constants here being positive and depending on $\|\|\tilde{m}\|\|, X$ only!),

\rho_{1}^{\varepsilon}(x) \leq & \exp \left[\frac{C_{2}(\delta)}{\varepsilon^{2}}+\frac{\tilde{m}_{0} h(x)}{\varepsilon}\right]\left(\mathbb{E}\left[p_{0}\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}\right)\right]^{\frac{1+\delta}{\delta}}\right)^{\frac{\delta}{1+\delta}} \\
& \times\left(\mathbb{E} \exp \left[-\frac{C(\delta)}{\varepsilon} \int_{0}^{1 / \varepsilon}\left|\tilde{Z}_{s}^{\varepsilon, x}\right|^{2} d s\right]\right)^{\frac{\delta}{q(1+\delta)}} \\
& \leq \exp \left[\frac{C_{3}(\delta)}{\varepsilon^{2}}\right]\left(\mathbb{E} \exp \left[-\frac{C(\delta)}{\varepsilon} \int_{0}^{1 / \varepsilon}\left|\tilde{Z}_{s}^{\varepsilon, x}\right|^{2} d s\right]\right)^{\frac{\delta}{q(1+\delta)}}
\end{aligned}
$$

It thus remains to estimate the last factor in the above right-hand side. Define $\tau=$ $\inf \left\{t>0:\left|\tilde{Z}_{s}^{\varepsilon, x}\right|<x / 2\right\}$ and fix $\eta>0$. We claim that for some $\eta>0$ small enough, it holds that for some $C_{\eta}>0, x_{0}$ and all $|x| \geq x_{0}$,

\end{equation*}
$$

from which one easily concludes the bound

\rho_{1}^{\varepsilon}(x) \leq \exp \left[\frac{C_{4}(\delta)}{\varepsilon^{2}}-\frac{C x^{2}}{\varepsilon}\right] \tag{4.5}
\end{equation*}
$$

for some constants $C_{4}(\delta)$ and $C$ depending on $\delta,\| \| \tilde{m}\| \|, X$ only.
On the other hand, define the event

Then there exists a constant $C_{3}>0$ depending on $C$ such that $\mathbb{P}\left(A_{C}\right) \geq C_{3}$. Note that on the event $A_{C}$, because $h^{\prime}(\cdot)>0$ and $h, b$ are Lipschitz, Gronwall's inequality implies that $\sup _{|x| \leq 1, s \leq 1 / \varepsilon}\left|\tilde{Z}_{s}^{\varepsilon, x}\right| \leq C^{\prime}$ for some constant $C^{\prime}$ depending on $C, \tilde{m}, X$ only. Thus, on the event $A_{C}$,

where $C_{4}$ depends only on $\tilde{m}, X$ and the constants in Assumptions (A-1)-(A-4). Hence (cf. (2.2)), there exists a constant $C_{2}$ (again, depending on the same quantities only) such that, uniformly in $|x|<1$,

Hence, denoting $C_{3}=\| \| \tilde{m}\| \| \sup _{x} h^{\prime}(x)$, it follows that the event $\{\tau<\eta\}$ is contained in the event

$$

if one chooses $\eta$ small enough and $x$ large enough. We have that

for some constant $C$, which completes the proof of (4.3).
Proof of Lemma 3.4. We prove only (3.7), the proof of (3.8) being similar. All we need to show is that for all $\varepsilon \leq \varepsilon_{0},|x| \leq M_{1} / \sqrt{\varepsilon}$, and some $M_{2}$,

+\frac{1}{\sqrt{\varepsilon}} \int_{0}^{1 / \varepsilon} h\left(\tilde{Z}_{t}^{\varepsilon, x}\right) d \tilde{W}_{t}+\int_{0}^{1 / \varepsilon} g_{3, \varepsilon}\left(\tilde{Z}_{t}^{\varepsilon, x}, \tilde{m}_{t}\right) d t+\log p_{0}\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}\right),
\end{array}
$$

where

g_{3, \varepsilon}(z, m)=g_{1}(z, m)-b(z) h(z)+\frac{1}{2} h^{\prime}(z)+\frac{1}{2 \varepsilon} m^{2}\left(h^{\prime}(z)\right)^{2} .
$$

Note that $\log p_{0}(\cdot)$ is bounded above, and

Now since, for any $p>1$,

it follows from Hölder's inequality that for any $q>p>1$ satisfying $1 / p+1 / q=1$,

& \left.\left.\times \exp \left(-\frac{q}{2 \varepsilon} \int_{0}^{1 / \varepsilon}\left|h\left(\tilde{Z}_{t}^{\varepsilon, x}\right)-h\left(\tilde{m}_{t}\right)\right|^{2} d t+\frac{p}{2 \varepsilon} \int_{0}^{1 / \varepsilon}\left|h\left(\tilde{Z}_{t}^{\varepsilon, x}\right)\right|^{2} d t\right)\right]\right)^{1 / q}
\end{align*}
$$

where $C>0$. However, note that, due to $h^{\prime} \geq h_{0}$, there exists a constant $C$ depending on $|||\tilde{m} \||$ such that

We prove below that, provided $M_{2}$ is large enough, there exists a $c>0$ such that

Setting $f(z, m)=-h(z)+m h^{\prime}(z)-\varepsilon b(z)$, we have that, for $|z| \in\left[M_{2} / 4 \varepsilon, M_{2} / \varepsilon\right]$, $t \leq 1 / \varepsilon$, and $\varepsilon$ small enough, it holds that $h_{0} M_{2} / 8 \varepsilon \leq\left|f\left(z, \tilde{m}_{t}\right)\right| \leq 2 H M_{2} / \varepsilon$ and $\operatorname{sign} f\left(z, \tilde{m}_{t}\right)=-\operatorname{sign}(z)$. Then, choosing $\eta=(16 H)^{-1}$ for each $i$, it holds that

& \leq \mathbb{P}\left(\sqrt{\varepsilon} \sup _{0 \leq t \leq \eta}\left|W_{t}\right| \geq \frac{M_{2}}{8 \varepsilon}\right) \\
& \leq \exp \left(-\frac{c M_{2}^{2}}{\varepsilon^{3} \eta}\right) .
\end{aligned}
$$

Similarly

\mathbb{P}\left(\theta_{i}-\tau_{i} \geq \eta,\left|\tilde{Z}_{\tau_{i}+\eta}^{\varepsilon, x}\right| \geq \frac{M_{2}}{2 \varepsilon}\right) & \leq \mathbb{P}\left(\sqrt{\varepsilon} W_{\eta} \geq \frac{h_{0} M_{2} \eta}{8 \varepsilon}\right)  \tag{4.14}\\
& \leq \exp \left(-\frac{c M_{2}^{2} \eta}{\varepsilon^{3}}\right)
\end{align*}
$$

and

$$
\begin{align*}
\mathbb{P}\left(\sup _{t \in\left[\tau_{i},\left(\tau_{i}+\eta\right) \wedge \theta_{i}\right]}\left|\tilde{Z}_{t}^{\varepsilon, x}\right|>\frac{M_{2}}{\varepsilon}\right) & \leq \mathbb{P}\left(\sqrt{\varepsilon} \sup _{0 \leq t \leq \eta}\left|W_{t}\right| \geq \frac{M_{2}}{2 \varepsilon}\right)  \tag{4.15}\\
& \leq \exp \left(-\frac{c M_{2}^{2}}{\varepsilon^{3} \eta}\right)
\end{align*}
$$

Hence, using (4.13), (4.14), and (4.15),

completing the proof of (4.11).
We now turn to the lower bound of the right-hand side of (4.8). Let, with $M_{1}^{\prime}=$ $M_{1}+1$,

\mathbb{E}\left[L_{\varepsilon}\left(x, \frac{1}{\varepsilon}\right) \mathbf{1}_{\left\{\left\|\tilde{Z}^{\varepsilon, x}\right\| \leq M_{2} / \varepsilon\right\}}\right] & \geq \mathbb{E}\left[L_{\varepsilon}\left(x, \frac{1}{\varepsilon}\right) \mathbf{1}_{\left\{\left\|\tilde{Z}^{\varepsilon, x}\right\| \leq M_{1}^{\prime} / \sqrt{\varepsilon}\right\}}\right]  \tag{4.16}\\
& \geq \exp \left(-\frac{c^{\prime}}{\varepsilon^{5 / 2}}\right) \mathbb{P}\left(\left\|\tilde{Z}^{\varepsilon, x}\right\| \leq \frac{M_{1}^{\prime}}{\sqrt{\varepsilon}}\right)
\end{align*}
$$

Finally (4.8) follows from (4.12), (4.16), and the estimate

Assume, without loss of generality, that $x<y$. Fix, for $\delta$ given, a smooth, even, nonnegative function $c(z)$ such that $c(|z|)$ is nonincreasing, $c(z)=\sqrt{\delta}$ for $|z| \leq \kappa$, and $c(z)=0$ for $|z|>2 \kappa$, with $\left\|c^{\prime}\right\| \leq 10 \sqrt{\delta}$. Define next the diffusions

d \xi_{s}^{2} & =\left[-h\left(\xi_{s}^{2}\right)+\tilde{m}_{s} h^{\prime}\left(\xi_{s}^{2}\right)-\varepsilon b\left(\xi_{s}^{2}\right)\right] d t+\sqrt{\varepsilon} d B_{s}, \quad \xi_{0}^{2}=y
\end{aligned}
$$

where $B$ is a Brownian motion independent of the process $\tilde{m}$, and $\tau=\min \left\{t: \xi_{t}^{1}=\right.$ $\left.\xi_{t}^{2}\right\} \wedge 1 / \varepsilon$. Note that $\xi^{2}$ coincides in distribution with $\tilde{Z}^{\varepsilon, y}$, whereas the law of $\xi^{1}$
is absolutely continuous with respect to the law of $\tilde{Z}^{\varepsilon, x}$ with the Radon-Nikodym derivative given by

& =\exp \left(\frac{1}{\varepsilon}\left[\bar{c}\left(\xi_{\tau}^{1}\right)-\bar{c}\left(\xi_{0}^{1}\right)\right]-\frac{1}{2 \varepsilon} \int_{0}^{\tau} c^{2}\left(\xi_{s}^{1}\right) d s-\frac{1}{\varepsilon} \int_{0}^{\tau} c\left(\xi_{s}^{1}\right) g\left(s, \xi_{s}^{1}\right) d s-\frac{1}{2} \int_{0}^{\tau} c^{\prime}\left(\xi_{s}^{1}\right) d s\right)
\end{align*}
$$

where $g(s, z)=-h(z)+\tilde{m}_{s} h^{\prime}(z)-\varepsilon b(z)$ and $\bar{c}(z)=\int_{0}^{z} c(y) d y$.
Next, note that with $\zeta_{s}=\xi_{s}^{1}-\xi_{s}^{2}$, and using that $x<y$, it holds that $\zeta_{s} \leq 0$ for all $s$, while by definition, $\left|\zeta_{0}\right| \leq \delta$. Hence, by the definition of $c(\cdot)$ and of $\kappa$, it holds that for all $\delta<\delta_{1}(\kappa,|||m| \|)$,

& \leq 2 \mathbb{E}_{B}\left(\mathbf { 1 } _ { \{ \| \xi ^ { 2 } \| < ( M _ { 2 } + 1 ) / \varepsilon \} } \operatorname { e x p } \left(\frac{C_{2} \sqrt{\delta}}{\varepsilon}+I_{\varepsilon}\left(\xi_{t}^{2}+\zeta_{t}, 0\right)\right.\right. \\
&\left.\left.\quad+\int_{0}^{t}\left(g_{1}\left(\xi_{s}^{2}+\zeta_{s}, \tilde{m}_{s}\right)+\frac{1}{\varepsilon} g_{2}\left(\xi_{s}^{2}+\zeta_{s}, \tilde{m}_{s}\right)\right) d s\right)\right) \\
& \leq 2 \mathbb{E}_{B}\left(\exp \left(\frac{C_{3} \sqrt{\delta}}{\varepsilon}+I_{\varepsilon}\left(\xi_{t}^{2}, 0\right)+\int_{0}^{t}\left(g_{1}\left(\xi_{s}^{2}, \tilde{m}_{s}\right)+\frac{1}{\varepsilon} g_{2}\left(\xi_{s}^{2}, \tilde{m}_{s}\right)\right) d s\right)\right) \\
&=2 \mathbb{E}\left(\exp \left(\frac{C_{3} \sqrt{\delta}}{\varepsilon}+I_{\varepsilon}\left(\tilde{Z}_{t}^{\varepsilon, y}, 0\right)+\int_{0}^{t}\left(g_{1}\left(\tilde{Z}_{s}^{\varepsilon, y}, \tilde{m}_{s}\right)+\frac{1}{\varepsilon} g_{2}\left(\tilde{Z}_{s}^{\varepsilon, y}, \tilde{m}_{s}\right)\right) d s\right)\right) \\
&= 2 \exp \left(\frac{C_{3} \sqrt{\delta}}{\varepsilon}\right) \mathbb{E} L_{\varepsilon}(y, t) \\
& \leq 4 \exp \left(\frac{C_{3} \sqrt{\delta}}{\varepsilon}\right) \mathbb{E}\left(\mathbf{1}_{\left\{\left\|\tilde{Z}^{\varepsilon, y}\right\|<M_{2} / \varepsilon\right\}} L_{\varepsilon}(y, t)\right),

& \quad-\frac{1}{\varepsilon} \int_{0}^{T}\left(\frac{\left[h\left(\bar{Z}_{s}^{\varepsilon, x}\right)-h\left(\tilde{m}_{s}\right)\right]^{2}}{2}+\frac{b^{2}\left(\bar{Z}_{s}^{\varepsilon, x}\right) \varepsilon^{2}}{2}+\varepsilon b\left(\bar{Z}_{s}^{\varepsilon, x}\right) h\left(\bar{Z}_{s}^{\varepsilon, x}\right)\right. \\

& +\varepsilon \log \mathbb{E}\left[L_{\varepsilon}\left(X_{1}, \frac{1}{\varepsilon}-T, \theta^{T} \tilde{m}\right) \mathbf{1}_{\left\{\left\|\tilde{Z}^{\varepsilon}, X_{1}\right\|_{1 / \varepsilon-T} \leq M_{2} / \varepsilon\right\}}\right] . \tag{4.28}
\end{align*}
$$

Fixing now an $L$, and using as in (3.18) the uniform quadratic growth of $F(x, m)$ as $|x| \rightarrow \infty$ and $|m|<|||\tilde{m}|||$, one finds a compact set $\mathcal{K}^{L}$ such that

& \sup _{|m|<\left|||\tilde{m}| \|| x \in\left(\mathcal{K}^{L}\right)^{c}, z \in \mathbb{R}\right.} \sup _{\varepsilon} \frac{C_{2}}{\varepsilon}-\frac{C_{3}(|z|-|x|)_{+}^{2}}{\varepsilon}+\frac{C_{5}(|x|+|z|)}{\varepsilon}-F(x, m) \\
& \quad \leq-F\left(X_{1}, X_{1}\right)-\frac{C_{6}+L}{\varepsilon} \tag{4.29}
\end{align*}
$$

and hence, from (4.27) and (4.28), for $x \in\left(\mathcal{K}^{L}\right)^{c} \cap\left[-M_{1} / \sqrt{\varepsilon}, M_{1} / \sqrt{\varepsilon}\right]$,

\begin{equation*}
\varepsilon \log \rho_{1}^{\varepsilon}(x) \leq \inf _{\left|y-X_{1}\right| \leq 1} \varepsilon \log \rho_{1}^{\varepsilon}(y)-L \tag{4.30}
\end{equation*}
$$

Hence,

\begin{align*}
& \limsup _{\varepsilon \rightarrow 0} \varepsilon \log \int_{\left(\mathcal{K}^{L}\right)^{c}} q_{1}^{\varepsilon}(x) d x=\limsup _{\varepsilon \rightarrow 0} \varepsilon \log \int_{\left(\mathcal{K}^{L}\right)^{c} \cap\left[-M_{1} / \sqrt{\varepsilon}, M_{1} / \sqrt{\varepsilon}\right]} q_{1}^{\varepsilon}(x) d x \quad \text { by }  \tag{4.31}\\
& \quad \leq \limsup _{\varepsilon \rightarrow 0}\left[\varepsilon \log \int_{\left(\mathcal{K}^{L}\right)^{c} \cap\left[-M_{1} / \sqrt{\varepsilon}, M_{1} / \sqrt{\varepsilon}\right]} \rho_{1}^{\varepsilon}(x) d x-\varepsilon \log \int_{\left[X_{1}-1, X_{1}+1\right]} \rho_{1}^{\varepsilon}(x) d x\right] \\
& \quad \leq \limsup _{\varepsilon \rightarrow 0}\left[\varepsilon \log \left(\frac{2 M_{1}}{\sqrt{\varepsilon}}\right)+\inf _{\left|y-X_{1}\right| \leq 1} \varepsilon \log \rho_{1}^{\varepsilon}(y)-L-\inf _{\left|y-X_{1}\right| \leq 1} \varepsilon \log \rho_{1}^{\varepsilon}(y) \varepsilon \log 2\right] \\
& \quad \leq-L . \\
& \text { by }(4.30)
\end{align*}
$$

This completes the proof.
Appendix. Derivation of (2.1). We first recall Picard's theorem [7, Proposition 4.2]: under the assumptions of the current paper and with the same notation, a version of the conditional unnormalized density is given by

\rho_{1}^{x, y}= & \log p_{0}\left(\bar{X}_{1}^{x}\right)+\frac{1}{\varepsilon} F\left(\bar{X}_{1}^{x}, 0\right)-\frac{1}{\varepsilon} \int_{0}^{1} h\left(\bar{m}_{s}\right) d \bar{X}_{s}^{x}-\frac{1}{\varepsilon} \int_{0}^{1} h\left(\bar{X}_{s}^{x}\right) b\left(\bar{m}_{s}\right) d s \\
& +\frac{1}{\varepsilon} \int_{0}^{1} \bar{m}_{s} h^{\prime}\left(\bar{X}_{s}^{x}\right) d \bar{X}_{s}^{x}+\frac{1}{2 \varepsilon} \int_{0}^{1} \bar{m}_{s} h^{\prime \prime}\left(\bar{X}_{s}^{x}\right) d s \\
& +\frac{1}{\varepsilon} \int_{0}^{1}\left[b\left(\bar{X}_{s}^{x}\right)\left(h\left(\bar{X}_{s}^{x}\right)-h\left(\bar{m}_{s}\right)\right)-\frac{1}{2} h^{\prime}\left(\bar{X}_{s}^{x}\right)-\varepsilon b^{\prime}\left(\bar{X}_{s}^{x}\right)\right] d s, \\
d \bar{X}_{s}^{x}= & -\frac{1}{\varepsilon}\left(h\left(\bar{X}_{s}^{x}\right)-h\left(\bar{m}_{s}\right)\right) d s-b\left(\bar{X}_{s}^{x}\right) d s+d W_{s}, \quad \bar{X}_{0}^{x}=x,
\end{aligned}
$$

$W$. is a Brownian motion, and $\tilde{\mathbb{E}}^{\prime}$ denotes expectation with respect to this Brownian motion. Performing a time change $t \mapsto \varepsilon t$ and setting $\tilde{W}_{t}=\frac{1}{\sqrt{\varepsilon}} W_{\varepsilon t}$, we have that $\tilde{W}_{t}$ is again a standard Brownian motion and, with $\bar{X}_{t}^{\varepsilon, x}=\bar{X}_{\varepsilon t}^{x}$,

\rho_{1}^{x, y}= & \log p_{0}\left(\bar{X}_{1 / \varepsilon}^{\varepsilon, x}\right)+\frac{1}{\varepsilon} F\left(\bar{X}_{1 / \varepsilon}^{\varepsilon, x}, 0\right)-\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} h\left(\tilde{m}_{s}\right) d \bar{X}_{s}^{\varepsilon, x}-\int_{0}^{1 / \varepsilon} h\left(\bar{X}_{s}^{\varepsilon, x}\right) b\left(\tilde{m}_{s}\right) d s \\
& +\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} \tilde{m}_{s} h^{\prime}\left(\bar{X}_{s}^{\varepsilon, x}\right) d \bar{X}_{s}^{\varepsilon, x}+\frac{1}{2} \int_{0}^{1 / \varepsilon} \tilde{m}_{s} h^{\prime \prime}\left(\bar{X}_{s}^{\varepsilon, x}\right) d s \\
& +\int_{0}^{1 / \varepsilon}\left[b\left(\bar{X}_{s}^{\varepsilon, x}\right)\left(h\left(\bar{X}_{s}^{\varepsilon, x}\right)-h\left(\tilde{m}_{s}\right)\right)-\frac{1}{2} h^{\prime}\left(\bar{X}_{s}^{\varepsilon, x}\right)-\varepsilon b^{\prime}\left(\bar{X}_{s}^{\varepsilon, x}\right)\right] d s, \\
d \bar{X}_{s}^{\varepsilon, x}= & -\left(h\left(\bar{X}_{s}^{\varepsilon, x}\right)-h\left(\tilde{m}_{s}\right)\right) d s-\varepsilon b\left(\bar{X}_{s}^{\varepsilon, x}\right) d s+\sqrt{\varepsilon} d \tilde{W}_{s}, \quad \bar{X}_{0}^{\varepsilon, x}=x,
\end{aligned}
$$

and

$$
\begin{equation*}
\left.\tilde{q}(1, x)=\exp \left\{\frac{1}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{m}_{s}\right)\right) d s-\frac{1}{\varepsilon} F\left(x, \tilde{m}_{0}\right)\right\} \tilde{\mathbb{E}}\left[\exp \rho_{1}^{y, x}\right] \tag{A.2}
\end{equation*}
$$

where the expectation now is with respect to the Brownian motion $\tilde{W}_{t}$.

Observe next that, by Girsanov's theorem, the law of the process $\bar{X}_{t}^{\varepsilon, x}$ is absolutely continuous with respect to that of the process $\tilde{Z}_{t}^{\varepsilon, x}$, with the Radon-Nikodym derivative given by

& -\frac{1}{2 \varepsilon} \int_{0}^{1 / \varepsilon}\left[h\left(\tilde{Z}_{s}^{\varepsilon, x}\right)-h\left(\tilde{m}_{s}\right)+\varepsilon b\left(\tilde{Z}_{s}^{\varepsilon, x}\right)\right]^{2} d s  \tag{A.3}\\
& \left.+\frac{1}{2 \varepsilon} \int_{0}^{1 / \varepsilon}\left[h\left(\tilde{Z}_{s}^{\varepsilon, x}\right)-\tilde{m}_{s} h^{\prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right)+\varepsilon b\left(\tilde{Z}_{s}^{\varepsilon, x}\right)\right]^{2} d s\right] .
\end{align*}
$$

Hence, with $\mathbb{E}$ denoting expectations with respect to the Brownian motion $\tilde{W}_{t}$ appearing in the definition of $\tilde{Z}_{t}^{\varepsilon, x}$, (A.2) transforms to

\left.\tilde{q}(1, x)=\exp \left\{\frac{1}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{m}_{s}\right)\right) d s-\frac{1}{\varepsilon} F\left(x, \tilde{m}_{0}\right)\right\} \mathbb{E} \exp \left[\Lambda_{1}(x)\right]
$$

where

\begin{aligned}
\Lambda_{1}(x)= & \Lambda+\log p_{0}\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}\right)+\frac{1}{\varepsilon} F\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}, 0\right)-\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} h\left(\tilde{m}_{s}\right) d \tilde{Z}_{s}^{\varepsilon, x}-\int_{0}^{1 / \varepsilon} h\left(\tilde{Z}^{\varepsilon, x}\right) b\left(\tilde{m}_{s}\right) d s \\
& +\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} \tilde{m}_{s} h^{\prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d \tilde{Z}_{s}^{\varepsilon, x}+\frac{1}{2} \int_{0}^{1 / \varepsilon} \tilde{m}_{s} h^{\prime \prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right) d s \\
& +\int_{0}^{1 / \varepsilon}\left[b\left(\tilde{Z}_{s}^{\varepsilon, x}\right)\left(h\left(\tilde{Z}_{s}^{\varepsilon, x}\right)-h\left(\tilde{m}_{s}\right)\right)-\frac{1}{2} h^{\prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right)-\varepsilon b^{\prime}\left(\tilde{Z}_{s}^{\varepsilon, x}\right)\right] d s \\
= & \log p_{0}\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}\right)+\frac{1}{\varepsilon} F\left(\tilde{Z}_{1 / \varepsilon}^{\varepsilon, x}, 0\right)+\int_{0}^{1 / \varepsilon} g_{1}\left(\tilde{Z}_{s}^{1 / \varepsilon}, \tilde{m}_{s}\right) d s+\frac{1}{\varepsilon} \int_{0}^{1 / \varepsilon} g_{2}\left(\tilde{Z}_{s}^{1 / \varepsilon}, \tilde{m}_{s}\right) d s .
\end{aligned}
$$

Since $\int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{m}_{s}\right) d s$ does not depend on $x$, taking

$$
\left.\rho_{1}^{\varepsilon}(x)=\tilde{q}(1, x) \exp \left\{-\frac{1}{2 \varepsilon} \int_{0}^{1 / \varepsilon} h^{2}\left(\tilde{m}_{s}\right)\right) d s\right\}
$$

gives a version of the unnormalized conditional density that coincides with (2.2).
